Problems resulting in suspension or occurring in more than 1 year qualifies as +1 or +4.</p> <p>Slight/Moderate Examples: suspension for smoking on school property, refusing to cooperate with assignments (detention, sent to principal..), minor aggression against peers, interfering with other student's class participation, talking back to teacher</p> <p>Severe Examples: serious act of aggression against another student resulting in suspension, an act of actual or attempted aggression against teacher, any bx problem that resulted in expulsion or persisted throughout elementary school</p> <p>Notes:</p>

Do not count a charge and conviction if they pertain to the same incident (double dipping). Discrepancy between the charge and conviction, use the most serious (generally the charge). Except when attempted murder, "attempted" offenses are scored as the offense itself.
